

# Position Vacant

## Tuckshop Convenor – Northview State School

Suitably qualified applicants are invited to apply for the position of Tuckshop Convenor at the Northview State School Tuckshop, operated by the P&C Association. The successful applicant will join a small friendly team of volunteers serving a primary school of approximately 400 students. This position is for an immediate start. Members of the public are invited to apply, as well as members of the school community.

**Hours:** Flexible. Currently run as Monday, Wednesday, Friday - 8am to 2pm. Approximately 18 hours per week. No work on public holidays or school holidays.

**Pay:** Casual position – Retail Manager Level 1. Award conditions and payment as per *Parents* and Citizens Associations Award – State 2016 (Qld). The current rate of pay is \$28.34/hr.

#### Details of the Role:

To oversee the day-to-day operation of the Tuckshop and be responsible for its effective and efficient operation within the guidelines and processes set by the School, the P&C Association, Education Queensland and the Queensland Association of School Tuckshops (QAST).

#### Duties will include:

- o Ordering and receiving or collecting stock from suppliers on a regular basis.
- o Maintain high standards of hygiene in storing, handling, preparing, and serving food and in accordance with any applicable mandatory food safety legislation.
- o Financial management processing daily takings, working within a set budget.
- Provide training, supervision, and support to all Tuckshop volunteers.
- o Prepare the volunteer roster and assist with the recruitment of new volunteers.
- Ensure a pleasant working environment for all volunteers.
- o Prepare a written report for the P&C President to present at monthly P&C meetings.
- o Perform a stock take at the end of each term.

#### **Desirable Qualities:**

- ESSENTIAL: A current Blue Card (Working with Children check). The successful applicant MUST hold a Blue card prior to commencing the role.
- Experience with food preparation and handling practices. Must have (or be willing to undertake training for) Food Safety Supervisor Certificate.
- o Demonstrated ability to follow procedures and direct instructions.
- o Demonstrated ability to work under pressure and meet deadlines.
- o Personal drive and integrity. Creative flair with food would be advantageous.
- Excellent interpersonal skills, including the ability to listen and communicate effectively and empathetically to achieve successful outcomes. Maintain positive and respectful relationships with students, parents, staff, P&C executives, suppliers, and other relevant parties.
- o Sound knowledge of key policies and legislation (including Workplace Health and Safety legislation, Student Protection Policy, Queensland Smart Choices Guidelines for schools).
